

# Recovery update for those affected by the Pigeon Valley Fire 5 April 2019

#### Sediment and ash

The risk of sediment and ash contamination of downstream waterways is being managed. A site visit was completed and expert advice has been given to determine methods that will reduce any negative effects. Funding is being sought to enable remediation.

## **Significant Natural Areas**

Within the fire areas we have Significant Natural Areas of native bush. The largest significant natural area is 54ha. This has been inspected and has been found to be significantly burned. The area is to become covenanted conservation land, whilst remaining in ownership of Tasman Pine Limited. The second largest (10ha) on Carter Holt Harvey land has not yet been inspected.

### Remediation

Property/land remediation visits commenced on 8 March 2019. All property visits have been completed. A preferred suppliers list was provided to landowners. Remediation work on many properties has been completed, other work is underway and others are about to start. The Land Remediation Team works through assessing the quotes received from the landowners (for the damage caused by firefighting) ensuring that quotes are reasonable and meet criteria before work commences.

### Mayoral Disaster Relief Fund (MDRF)

If you have costs from the fire event which are not covered by insurance or other means **put in an application to the MDRF**. When applying to the MDRF please make sure you attach any supporting documents, as applications cannot be processed until those documents are received. If you have applied but haven't already attached any supporting documents, please email them to <a href="mailto:Sandie.Hutchinson@tasman.govt.nz">Sandie.Hutchinson@tasman.govt.nz</a>. If there are no supporting documents please explain why on your application.

So far payments from the Mayoral Disaster Relief Fund have been made for accommodation, loss of income, remediation works and financial hardship.

#### **Fencing**

Please come along to the Rural Support Trust fencing workshop Wednesday 10 April at 2pm at Tim King's property at 309 Eves Valley Rd. John Noakes from the Fencing Contractors Association will set up demonstrations on netting, stays and wiring which will take about 3 hours, to be followed by a BBQ.



Some information about funding for repair and replacement of fencing:

- Fencing that was damaged in controlling the fire i.e. during creation of firebreaks. We are trying to procure funding from the Government to fund this type of remediation.
- Fencing burnt by the fire. Funding for this should come via individual property insurance or if
  no insurance is available, a claim can be made to the Mayoral Disaster Relief Fund for
  consideration.

### Reseeding

A pasture recovery blend recommended by Farmlands is provided at a subsidised rate to landowners whose properties have been affected by the fire. Reseeding will be done by helicopter tomorrow (Saturday 6 April). Please take care of your horses and other animals.

#### Healthcare

**Free GP visits for fire-related stress or anxiety:** Free GP visits will continue to be offered for people seeking support for stress or anxiety relating to the fires.

**Coping with stress and anxiety:** Anxiety is a normal response to a very stressful situation. Talking to people and helping others can be both therapeutic and useful.
